- Importer of Motor Vehicle Equipment** - a person that imports motor vehicle equipment for resale
- Importer of Motor Vehicles Originally Manufactured to Conform to FMVSS** - a person that imports motor vehicles originally manufactured to conform to FMVSS for resale as distinguished from registered importers subject to the duties specified in 49 CFR Part 592
