We use FedCert Suite software, version 4.0.0.2012 to calculate our VIN numbers. Our VIN numbers are made up of the following positions and their meaning (see attached "Vehicle Identification Number, Vehicle Type: TRAILER" for reference):

Position 1, 2 & 3- World Manufacturer Identifier Code "1J9" (see attached "SAE International" for reference)

Position 4- Type of trailer. Our identifiers are:

- "B"- Bumper Pull
- "G"- Gooseneck
- "P"- Pintle Hitch

Position 5- Body Type. Our identifiers are:

- "P"- Pigeon Trailer
- "D"- Dog Trailer Aluminum
- "S"- Dog Trailer Stainless Steel
- "E"- Enclosed Adoption/Rescue Trailer
- "F"- Flatbed Trailer
- "H"- Horseshoeing Trailer
- "C"- Cargo Trailer
- "T"- Enclosed Trailer

Position 6 & 7- Length of Trailer. Our identifiers are:

- "01 – 09"- One foot to Nine feet in length
- "10 – 53"- Ten feet to Fifty-Three feet in length

Position 8- Number of Axles. Our identifiers are:

- “1”- Single Idler Axle
- “2”- Two Braking Axles
- “3”- Three Braking Axles
- “4”- Single Braking Axle

Position 9- Check Digit. Calculated by software program

Position 10- Model Year. Our identifiers are:

- “A”- 2010
- “B”- 2011
- “C”- 2012
- “D”- 2013
- “E”- 2014
- “F”- 2015
- “G”- 2016
- “H”- 2017
- “J”- 2018
- “K”- 2019
- “L”- 2020

(use all letters in the alphabet EXCEPT “I”, “O”, “Q”, “U” and “Z”)

Position 11- Plant. Our identifiers are:

- “D”- Denton, NC (we only have one plant)

Position 12, 13 & 14- World Manufacturer Identifier Code “349” (see attached “SAE International” for reference)

Position 15, 16 & 17- Sequential Production Number. Our identifiers are:


Numbers starting with “001” and progressing higher with each trailer manufactured.
